General Notifications

Pre-Bid Meeting Minutes

The non-mandatory pre-bid meeting was conducted on November 10th, 2025.

Bidding Questions and Answers

The below questions have been submitted either electronically or asked during the pre-bid walkthrough.

- Question 1: what is the wire gauge of the two medium voltage circuits 205 & 224?
- Answer 1: The 2020 Arc Flash Study report, provided by Indiana University, indicates both circuits are 350 kcmil.
- Question 2: Is it possible to obtain the IU supplied equipment submittals?
- Answer 2: Not currently, the pre-purchase equipment bids have not been received yet.
- Question 3: Where is the vault for the Sports Rec feed?
- Answer 3: Based on as-built records, provided by Indiana University, there is a manhole just northeast edge of Harper Hall. See attached as-built sheet E1.03
- Question 4: Is the existing switchgear pad to be demolished? Repair damaged concrete below after demolition?
- Answer 4: Yes, demo the existing concrete pad and repair.
- Question 5: On the medium voltage cable replacement, that is included in the base bid, does the existing cable have modular splices in the manhole? Do I need to include new modular racking?
- Answer 5: Both circuits will require modular T splices and racking.



Question 6: For the alternate bid, I need to know where the manhole is located and if there are T mods and racking.

Answer 6: Based on Sports Rec as-builts, the first manhole from Harper should be located at the northeast edge of the building. It is not known if the cable has T-mods or racking in that manhole.

Question 6: I would like to request a bid extension. The crane operators cannot provide a quote by November 25th.

Answer 6: Yes, the bid date will be changed to December 4th.




